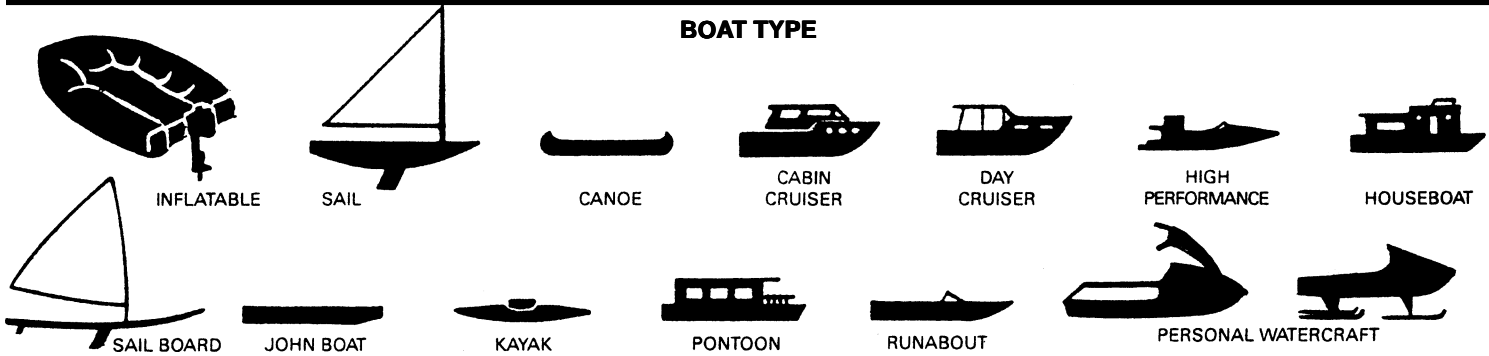

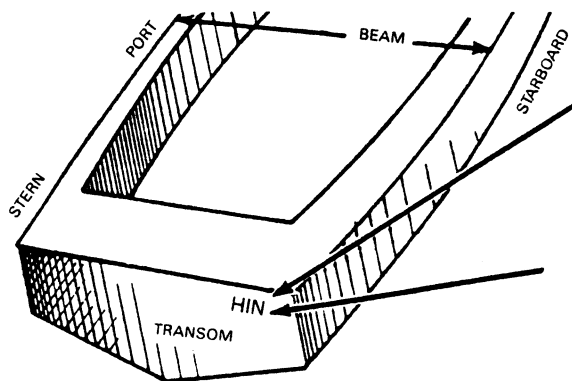
BOAT TYPE
